Academy of Fine Arts Leipzig / Hochschule für Grafik und Buchkunst Leipzig (HGB Leipzig) Academy Fee and Charge Regulations

Effective from 11 July 2019

On 20 June 2019, and in consultation with the Senate, the Rectorate issued the following Academy Fee and Charge Regulations, in accordance with Sect. 12(8), Sentence 1, and Sect. 13(5), Sentence 2, of the Freedom of Institutions of Higher Education in the Free State of Saxony Act (Sächsisches Hochschulfreiheitsgesetz, SächsHSFG) of 15 January 2016 (as published in the Saxon gazette SächsGVB1, p. 3), last modified on 5 April 2019 (SächsGVB1, p. 782).

§ 1 Scope

- (1) The Academy of Fine Arts Leipzig (Hochschule für Grafik und Buchkunst, HGB Leipzig) levies fees, expenses and charges in accordance with these regulations for the use of its facilities and services.
- (2) The party liable for fees, expenses and charges is the person:
 - 1. who uses the facilities or services of the Academy
 - 2. in whose interest the facilities or services are used
 - 3. who assumes responsibility in writing for the payment of user fees and expenses owed to the Academy or who is liable for the debt of another person under law
- (3) If several parties are responsible for the fees and charges, they are liable as joint debtors.
- (4) This regulation does not apply to internal cost allocations and transfers.

§ 2 Fees and Charges

- (1) Fees are defined as public charges levied for separately attributable public services or fulfilment of official acts which are chargeable to the beneficiary or liable person in order to fully or partially cover the public expense.
- (2) Charges shall be defined as considerations agreed upon for the use of facilities and services as part of a private-law contract, through which the service-providing organisational unit of the HGB Leipzig potentially competes with private providers.
- (3) The HGB Leipzig will levy fees and charges for:
 - 1. long-term studies in accordance with Sect. 12(2) of the SächsHSFG
 - 2. a second course of studies in accordance with Sect. 12(4) of the SächsHSFG, if the student already holds a master's, diploma or magister degree in a degree programme with a final state or church exam, provided that the total duration of their studies exceeds the prescribed period of study of their previous degree programme by six months or more

- 3. postgraduate studies
- 4. auditors
- 5. examinations of knowledge acquired externally in accordance with Sect. 37(2) of the SächsHSFG
- 6. participation in the HGB's Evening Academy (Abendakademie)
- 7. use of the HGB Leipzig facilities, especially the HGB Library and the HGB Archive, provided they are not generally free of charge
- 8. any fees and/or charges for additional services not covered in the appendices of these regulations; fees or charges are determined by the Department of Finance/Procurement in consultation with the service- providing organisational unit of the HGB Leipzig
- (4) The individual fees and charges are determined by Sect. 12 of the SächsHSFG and the appendices of these regulations.

§ 3 Costs for Official Acts

- (1) The HGB Leipzig will levy administrative fees and expenses for activities it carries out in performance of its sovereign duties (official acts) and in accordance with the Administrative Costs Act of the Free State of Saxony (Verwaltungskostengesetz des Freistaates Sachsen, SächsVwKG) of 17 September 2003 (as published in the Saxon gazette SächsGVB1, p. 698), as amended.
- (2) In accordance with Sect. 1 combined with Sect. 12 and Sect. 13 of the SächsVwKG, expenses are defined as expenditures incurred in connection with an official act or the use of services or facilities not covered by existing fees and charges. They will be levied in addition to any existing fees or charges. Expenses generally include:
 - remuneration of experts
 - charges for postal and telecommunication services
 - contributions due for services by public authorities, institutions or other persons
 - document fees

- (3) The costs are determined by the Saxon Schedule of Values (Sächsisches Kostenverzeichnis) as amended, provided they are not determined by these regulations.
- (4) Expenses in the sense of Sect. 2 will be levied even if payments have not yet been made to other authorities, institutions or persons for reasons of administrative ease or similar reasons.
- (5) Any appeal proceedings are determined by Sect. 11 of the SächsVwKG.

§ 4 Incurrence and Due Date

- (1) Fees, expenses and charges are incurred in connection with the use of the Academy's facilities and services.
- (2) Fees, expenses and charges are due as soon as they have been imposed unless the Academy has specified a different date.
- (3) Fees, expenses and charges may be levied in advance.
- (4) If the public service is subject to value-added tax, this will be passed on to the person liable for the fees and expenses. User fees and expenses for services subject to value-added tax will be increased by the amount of the statutory value-added tax.

§ 5 Deferrals / Instalment Payments / Waivers

- (1) The HGB Leipzig may defer fees, expenses and charges in individual cases upon written request if immediate collection would be associated with considerable hardship, provided that the claim will not be compromised by the deferral. The deferral will be granted against appropriate interest and, under normal circumstances, only against collateral security.
- (2) The HGB Leipzig may agree to have fees, expenses and charges paid in instalments upon written request if the collection of the total sum would be associated with considerable hardship, provided that the claim will not be compromised by payment in instalments. However, the outstanding balance will become due immediately if the due date of an instalment is exceeded by a period

to be specified in a corresponding agreement.

- (3) The HGB Leipzig may fully or partially waive fees in individual cases upon written request if their payment would cause considerable hardship. A waiver is only possible if deferral or instalment payments as per Sect. 1 and Sect. 2 cannot be taken into consideration. Charges and expenses cannot be waived.
- (4) Written requests for deferrals, instalment payments and waivers must be submitted to the Department of Finance/Procurement no later than the date the claim is due. Any decisions on requests for deferral and instalment payments will be made by the Department for Finance/Procurement on behalf of the Chancellor following a hearing of the structural unit responsible for levying the fees and charges and taking into consideration the provisions of the Saxon Higher Education Financial Regulations (Sächsische Hochschulfinanzordnung). Any decisions regarding waiver requests will be made by the Chancellor taking into consideration the audit results of the Department of Finance/Procurement.
- (5) Deferrals and instalment payments are determined by Sect. 5(1) of the SächsHSFinVO. Waivers are determined by Sect. 5(3) of the SächsHSFinVO. In addition, the Administrative Regulations from the Saxon State Ministry of Finance in Sect. 59 of the Saxon Budget Regulations (Sächsische Haushaltsordnung) of 27 June 2005 apply as amended.

§ 9

Transitional Regulations

Fees, expenses and charges that were incurred before this regulation entered into force are determined by the previous Fee and Charge Regulations of the HGB Leipzig as amended.

§ 10 Entry into Force / Expiry

These regulations come into force on the day following their publication. They also replace the Fee and Charge Regulations of the Academy of Fine Arts Leipzig of 21 December 2010, as amended on 26 April 2012 and 6 August 2018.
